This release extends to any and all claims I have or may have against the released parties, even if such claims result from strict liability or negligence on the part of any or all of the released parties, or concerning the conditions, qualifications, instructions, rules or procedures under which the ride is conducted, or from any other cause. However, I do not release any released party from any intentional misconduct on its part.

I hereby state I am experienced in and familiar with the operation of various motorcycles and fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in the ride as a rider and/or as a passenger and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might suffer as a result of my participation in the ride I am participating in the ride knowing the existing weather conditions, road conditions and other similar conditions and factors associated with this ride.
